Refund Policy

Returns (If applicable)

Our policy lasts 30 days. If 30 days have gone by since your purchase, unfortunately we can't offer you a refund or exchange.

To be eligible for a return, your item must be unused and in the same condition that you received it. It must also be in the original packaging.

Several types of goods are exempt from being returned. Perishable goods such as food, flowers, newspapers or magazines cannot be returned. We also do not accept products that are intimate or sanitary goods, hazardous materials, or flammable liquids or gases.

Additional non-returnable items:

Cancellation Policy

The terms hereof shall constitute **Market Pulse (A division of Metrix Research & Analytics Pvt. Ltd.)** ("Company") cancellation and refund policy in relation to the Market Research rendered on the Website.

Cancellation and Refund:

1. Client satisfaction is our main priority. If we fail to provide services from our end, but the client has paid for the service then client will be liable to mention the same to us for cancellation, but in case there is a delay in service timeline and has been mutually discussed then the client cannot raise such mentions to us till the new timeline is expired. If the client changes its mind for the services taken for any reason whatsoever, we will not be liable to cancel the service. 2. If the contract so scheduled is approved for cancellation, the amount for refund shall be calculated based on the below mentioned formula:

3. The refund shall be credited back to the same instrument used as payment at the time of booking of appointment. For instance if client paid via net banking he/she will receive back the refund his/her bank account. In case client paid via credit card he/she will receive payment in credit card account.

4. The process of refund may take until 7 working days from our office. However, this period mentioned may extend the approximate timeline, as we depend on Third Party Payment Gateway Provider to complete the process. The refund time may be subjective depending on the time taken at the Third Party Payment Gateway.
